3. Options, strategy and costs to terminate the Police Officers' Pension Plan.

[This was discussed after item #4] Mr. Burke spoke about different scenarios including offering a lump sum option and possibly offering the retirees a lump sum option with IRS approval. If the IRS won't approve this, then there is another option of transferring the assets over to the fire plan. For those non-vested police officers in the plan who wouldn't elect the lump sum, they could then transfer to the fire plan. Mr. Carr would figure out the figures to be transferred out to the fire plan. Another possibility would be to combine the fire and general plans. This scenario would require approval from the Division of Retirement, Mr. Burke would check with the Division of Retirement. Commissioner Manley questioned the costs involved to make these changes.

4. Options and costs to add a pre-retirement death benefit.

[This was discussed before item #3] Mr. Carr provided an overview of the cost to add this benefit to the pension plans. Trustees discussed the different options, Mr.

City Manager Fred Hilliard verified what they would have the actuary look at for the cost estimate – they would look at a 50-60% death benefit going back 10 years for spouses only, and for active employees they would also include dependent children. They would work with the actuary to find out how to amortize. Mr. Carr clarified they would be narrowing this change to the active employees and those few who have passed away within the last 10 years.
