7. PUBLIC FORUM:

Meade, FL., was present concerning the property located behind her at 811 S Perry Ave. stating the property is in very bad disrepair and the grass is extremely high and invested with rodents and snakes. Mrs. Vaughn asked the Commission to have something done to take care of the problem.
