E. FMPA/Contract Rate of Delivery

City Attorney, Tom Cloud spoke on behalf of the City Manager, stating that FMPA are undergoing a legislative audit. He stated we are at cross-roads with them and there may be some litigation because of it.

10. CITY ATTORNEY COMMENTS:

A. City Attorney, Tom Cloud requests an Executive Session to discuss litigation strategy and expenses immediately following the regular meeting.

Motion Commissioner Watts, second Commissioner Cochrane immediately following this regular scheduled meeting to re-adjourn and go into executive session to discuss litigation.

11. CITY MANAGER COMMENTS:

Ms. Brown spoke on behalf of the City Manager:

A. City Mobile Home Park

There are currently 20 vacant mobile home sites. The City Manager has been in contact with Jacobson Homes to setup a park model. The displacement of the golf course to develop a RV Park would require the approval of the Home Owner's Association.

B. Update of Hwy 98 East Singleton Bridge.

Representatives with FDOT and JAI will be holding a project kick-off meeting on December 4, 2014 from 3:00 P.M till 8:00 P.M.at the City Mobile Home Park Activity Center. The City Manager encourages everyone to attend.

C. FMPA/ARP

The cost to terminate the interest rate swaps will be in the area of one hundred million dollars, \$100,000,000.00. Preliminary projections regarding this additional debt will cost the residents an estimated \$.50 per kilowatt on the demand side increasing cost to \$22.96 per kilowatt and a

\$1.15 per megawatt on the energy charges for \$32.62 per megawatt hour for the next 20 years.

12. CITY COMMISSION COMMENTS:

Commissioner Watts questioned if the City was having any problems with the radio-read water meters like Pasco County.

Commissioner Cochrane stated that staff notifies the customer if there is a significant increase in usage.

Commissioner Manley updated the Commission on the TPO meeting she attended and stated that they estimate the population of Polk County to increase 66.72% from 2010 to 2040, a rate of 22% per year.

Mayor Elliott asked Public Work Director, Jackie Cannon how the 98 East project was going.

Mr. Cannon stated that they are still moving along but they have to wait weeks on parts to come in.

13. STAFF REPORTS

April Brown stated that she met with the engineer for the FDOT to discuss the easements for the trail. She also stated that Duke Energy is on board with the project.

The Christmas decorations have come in and they are being refurbished and will be ready for Christmas.

14. <u>ADJOURNMENT</u>

There being no further business to conduct, Motion Commissioner Watts, second Commissioner Manley to adjourn the Regular Commission meeting of October 14, 2014 at 7:30 PM.
