

RESOLUTION NUMBER: R 20-31

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT MEADE, FLORIDA; APPROVING A TEMPORARY COVID-19 PANDEMIC FACILITY ASSEMBLY HALL SECTIONAL FEES REDUCTION BY THE CITY REGARDING COMMUNITY CENTER'S FEES; REPEALING PRIOR RESOLUTIONS INCONSISTENT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE OCTOBER 19, 2020 THROUGH DECEMBER 31, 2020.

WHEREAS, such is a necessary requirement of the Code of Ordinances of the City of Fort Meade, requiring the periodic review of fees, and charges for the various services provided, and;

WHEREAS, this Resolution amends a portion of R-15-15, and reaffirms other certain rates and charges established therein, and;

WHEREAS, it is the recommendation of the City Manager of the City of Fort Meade that the following fees and charges for services be established:

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Fort Meade, Florida as follows:

SECTION 1. The City of Fort Meade hereby establishes the following fees applicable to City's Community Center's Facility as set forth in "EXHIBIT "A"

SECTION 2. SEVERABILITY. If any section, sentence, clause, or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, that holding shall in no way affect the validity of the remaining portions of this Resolution.

SECTION 3. REPEAL. The City hereby repeals that portion of Resolution No. R-15-15, pertaining to City's Community Center's Facility Fees, which is superseded by this Resolution.

SECTION 4. EFFECTIVE DATE. This resolution shall become effective immediately upon adoption.
